Biography

He was also awarded full (100%) scholarship for the Finance and Banking Ph.D. Program of Kadir Has University in 2006 and earned his doctorate in 2009. Kızıl is also a Certified Public Accountant (CPA), Certified Internal Controls Auditor (CICA), Certified Controls Specialist (CCS), ISO27001 Lead Auditor and ISO9001 Lead Auditor. Dr.Cevdet Kızıl has several published books and articles in Turkey and internationally.
